Receipt date of entry determines starting position. Check, credit card, or money order must accompany this form to qualify for tournament entry. In signing this application, I verify that I have boating liability insurance in the amount of \$100,000. By my signature, I have read and understand the rules and the agreement provided by Anglers In Action Tournament Trail LLC/Midwest Fish Tournaments LLC. Entry forms that are not completed in full and signed by both parties will not be accepted.

Anglers in Action Team Trail: Annual membership fee is \$50.00 per angler. Entry fee is \$180 per qualifying tournament, per boat. There will be an optional \$20 Big Bass Pot and optional \$20 Sidepot at each tournament. Big Bass & Sidepot payment can accompany this form or can be paid at the ramp the morning of the tournament. You may include a \$20 deposit per tournament to reserve your boat number. Membership fee must be paid before fishing any tournament event. Reservation money will not be refunded unless the tournament is officially canceled. Boat position will transfer forward in the event of a rescheduled tournament.

The undersigned agree that they are knowingly and freely assuming all risks of participation in the Tournament and assume full responsibility for their participation in the Tournament.
