Receipt date of entry determines take-off position. Check, cash, credit card, or money order must accompany this form to qualify for tournament entry. In signing this application, I verify that I have boating liability insurance in the amount of \$100,000. Entry forms that are not completed in full and signed by both parties will not be accepted.
